IF YOU ARE OVER 70 AND HAVE AN IRA PLEASE READ THIS: If you are over 70 and have an Individual Retirement Account (IRA) the IRS requires you to make an annual withdrawal that is based on a combination of your age and the value of your IRA at the end of the preceding year. This withdrawal, called a Required Minimum Distribution or RMD, is generally treated as Taxable Income. However, there is a provision in the law that allows you to have some or all of the RMD made directly to a qualifying charity such as Faith Community. The IRS calls this a Qualified Charitable Distribution and if you do this it is not taxable. Note that while the RMD was suspended in 2020 due to the virus, we have no reason to believe the suspension will be continued. Some at Faith Community are already using this provision, but if you are not you should consider it. Talk to your financial advisor or broker to get more details to see if it would work for you. If doing this results in tax savings, you should consider adding some or all of the savings to your pledge.
